**Thammasat University Regulation, re:  
The Establishment and Administration of the Foreign Publish Fund (No. 2), B.E.  
2566**

Where it is deemed appropriate to amend the Thammasat University Regulations, re: The Establishment and Administration of the Foreign Publish Fund.

By virtue of Section 23 (2) and (4) of the Thammasat University Act, B.E. 2558, and by the resolution of the University Council from the 12/2566 Meeting, which took place on November 28<sup>th</sup>, 2023, it has been agreed to amend the aforementioned regulation, as follows.

**Article 1** – This Regulation is called “*Thammasat University Regulations, re: The Establishment and Administration of the Foreign Publish Fund (No. 2), B.E. 2566*”

**Article 2** – This Regulation shall come into force from the day after the announcement date onwards.

**Article 3** – The provision described under Article 4 of the Thammasat University Regulation, re: The Establishment and Administration of the Foreign Publish Fund, B.E. 2564, will be repealed and the following provision will be used instead.

*“Article 4 – The Rector shall maintain compliance with this Regulation and shall have the power to issue any announcements or orders of the university, as well as to interpret and make decisions and orders regarding this regulation. The Rector’s interpretation, decisions, and orders are final.”*

**Article 4** – The provision described under Article 8 of the Thammasat University Regulation, re: The Establishment and Administration of the Foreign Publish Fund, B.E. 2564, will be repealed and the following provision will be used instead.

*“Article 8 – There shall be a Committee appointed by the Rector, consisting of the following members.*

- (1) The Rector shall serve as the Chairman of the Committee.*
- (2) The Vice Rector for Research Administration shall serve as the Vice Chairman of the Committee*
- (3) The Vice Rector for Planning shall serve as a director.*
- (4) The Vice Rector for Academic Affairs shall serve as a director.*
- (5) The Vice Rector for Finance shall serve as a director.*
- (6) The Assistant to the Rector for Research Administration (if any) shall serve as a director.*
- (7) The President of the Faculty Senate shall serve as a director.*
- (8) Directors of the Academic Service Division, the Treasury Division, and the Planning Division shall serve as directors.*
- (9) Experts in the fields of Social Sciences, Humanities, Science and Technology, and Health Sciences, at most one expert from each field, shall be appointed by the Rector as directors.*
- (10) The Director of the Research Administration Division shall serve as a director and secretary of the Committee. In addition, the Director of the Research*

*Administration Division may appoint at most 2 other university workers as assistant secretaries.*

*Members of the Committee under Item (9) shall have a term of office of 2 years, and they can be reappointed.”*

**Article 5** – The provision described under Article 9 of the Thammasat University Regulation, re: The Establishment and Administration of the Foreign Publish Fund, B.E. 2564, will be repealed and the following provision will be used instead.

*“Article 9 – The Committee shall have the authority and duty to manage the Fund as per the objectives of the Fund, as follows.*

*(1) Consider and determine the guidelines and operational plans of the Fund while taking into account the university’s development goals.*

*(2) Consider and determine criteria and methods for allocating the Scholarship, qualifications of eligible applicants, the amount of scholarships to be allocated, and the expenses of the Scholarship; and issue these details as announcements of the University.*

*(3) Appoint sub-committees to consider and determine how to allocate the Fund, in accordance with the criteria determined by the Committee.*

*(4) Perform other duties assigned by the University Council.”*
